COOKIES POLICY

1. What are cookies?

Cookies are small text file stored on your computer or mobile device when visiting our website. While you interact with our websites, technologies from third-party providers such as scripts, pixels and tags, which we integrate on our websites for advertising purposes, also set cookies on your device.

2. Why AGP use it?

Cookies enable us to provide you core functionalities such as security, network management and accessibility. They improve usability and performance through various features such as language recognition, search results and thereby improve what we offer to you.

3. Categories for cookies

We divide data processing into various categories depending on its function and purpose.

3.1. Technical cookies

These cookies are intended to enable or facilitate electronic communication (detection of connection errors, identification of connection points, website security, etc.) or to provide online communication services which you might specifically request (screen display preferences, saving information entered in the forms, shopping cart [if applicable], access to your user account, etc.). You may not object to the use of these cookies.



3.2. Advertising cookies

These cookies may in particular process data relating to your personal preferences, your interests in our products and/or services, your consumption habits, etc. We can use tools to automatize the processing of your personal data to evaluate certain personal aspects relating to you and in particular to analyze or predict aspects concerning your personal preferences and needs. The data processed in this context may have been collected from different sources and may be interconnected: data from our customer files, navigation data, data from third parties, data on the use of your vehicle, etc. These processing are intended to push you personalized content related to certain personal aspects relating to you, such as dedicated offers by e-mails, personalized advertising, content on our websites related to your interests, etc.

The use and storage of these cookies is subject to your consent.

3.3. Analytics cookies

These cookies are intended to analyze website traffic and to improve your browsing experience. These cookies may in particular process data relating to the pages visited, the time spent on visited pages, the browser you use to visit these pages, etc. The use and storage of these cookies is subject to your consent.
